7. Are you happy with the final result? What would you change or ask for suggestions from those in attendance (we will be kind with our remarks☺)
8. If matted/framed, how did you decide what to use and did you do it yourself or have it professionally done (if so, by whom)?
9. Offer any other tips you may have.

This should be a fun process - no pressure, it is on a **voluntary** basis. You can talk off the cuff or, if you prefer, we can ask questions that you can respond to.

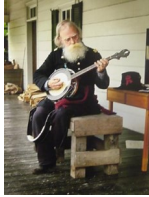

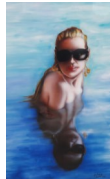
