## ELIGIBILITY

Participation is open to all artists 18 years or older. Recent works in 2-dimensional (3-dimensional if able to hang) media will be considered unless exhibited in previous Three Cities Art Club ("TCAC") Call for Artists event. Pieces must be properly wired for hanging and weigh no more than 20 pounds. TCAC membership is not required.

## ENTRY FEE

Non-refundable entry fee of **\$35 for up to three entries (\$25 for paid TCAC members; membership fee of \$25 can be paid at time of entry) and \$5 for each additional entry.** Each piece of art being submitted is considered one entry. Please make checks payable to Three Cities Art Club.

## ENTRY PROCEDURE

Entries must be postmarked no later than **Monday, November 12, 2018** with the total entry fee and signed Artist's release form **mailed to: Three Cities Art Club c/o Marilyn Meredith, 41021 Southwind, Canton, MI 48188-1321.**

Entries will be juried/judged from the original art to be delivered on **Wednesday, November 28, 2018 between 9 am and noon to Westland's Gallery at City Hall located at 36300 Warren Road, Westland, MI 48185.** Each piece must be labeled on back with **artist's name, title, selling price and artist's phone number.**

Please print clearly as you wish your name to appear on the show cards, in the program and Artists Profile Booklet. To be included in the "Artist's Profiles Booklet", we need pictures of your work, a photograph of yourself, and a short artist profile. Please email your electronic files to [marilynmeredith@wowway.com](mailto:marilynmeredith@wowway.com); pictures in jpeg format, approximately 800 DPI and a file size less than 2 MB with artist's last name and title as file name: i.e. MeredithFlowers.jpg or hard copies (max. 8" x 10") or on CD/flash drive with your name and title on the back of photographs.

**Photos and CDs/flash drives can only be returned if a self-addressed, postage paid, appropriate size envelope is provided with entry.**

## NOTIFICATION OF JUROR RESULTS/PICK-UP

Artists will be notified of juror's results by email or by phone Thursday, November 29. **Pick-up art not accepted 9:00 - 10:00 am on Friday, November 30, 2018.**

## RIGHTS AND REPRODUCTIONS

Three Cities Art Club and the City of Westland reserve the right to use provided images, photograph and reproduce all accepted entries, regardless of copyright, for the sole purpose of publicity.

## SALES

A TCAC **30% commission** will be charged on all sales (**15% for TCAC members**). **Credit card sales will be assessed a transaction fee of 5% of the sale price.** Artists are responsible for paying Michigan State sales tax. TCAC sales coordinator Marilyn Meredith's phone number will be printed on show cards and those interested in making a purchase will contact her so she can arrange to meet buyer at Gallery at City Hall to complete the transaction. TCAC will pay artists as soon as reasonably possible following the close of the exhibition. If buyer wants to take art, a "SOLD" sign will be hung in place of art.
