**Kenneth Hershenson** is a self-taught contemporary fine artist who creates hyperrealistic acrylic paintings. He has been drawing and painting for over 50 years. Architectural design and illustration are the basis of much of his professional life, which included serving as an architectural designer with *Disneyland* and designing Japan stores for *Starbucks*. His art influences include 17th century Flemish realists and the creativity and surrealist styles of Dali and Magritte.

Kenneth has participated in many juried art shows and has won a number of awards in watercolor, drawing and painting. He won the Award of Excellence from the *National Oil & Acrylic Painters' Society*, the People's Choice Award in the prestigious 2022 *Richeson75 International Still Life & Floral Exhibition* and very recently was a finalist in the 2023 Fall Salon Exhibit for the *International Guild of Realism*.

Mr. Hershenson is a member of the *National Oil & Acrylic Painters' Society*, the *International Guild of Realism* and a former member of the *Colored Pencil Society of America*. He is a former painting instructor with the *Atelier School of Art* in Oak, Michigan.

## ELIGIBILITY

Participation is open to all artists 18 years or older. Recent works in 2-dimensional media (3-dimensional if able to hang) will be considered unless exhibited in previous Three Cities Art Club ("TCAC") Call for Artists event. Pieces must be properly **wired for hanging and weigh no more than 20 pounds**. [TCAC membership is not required](#).

## ENTRY FEE

Non-refundable entry fee of **\$35 for up to two (2) entries (\$30 for paid TCAC members; membership fee of \$30 can be paid at time of entry) and \$10 for each additional up to 5 entries (\$7.50 for paid TCAC members)**. Each piece of art submitted is considered one entry (i.e. triptych would be 3 pieces). [Check payable to Three Cities Art Club](#).

## ENTRY PROCEDURE

Entries must be postmarked no later than **Wednesday, November 8, 2023** with the total entry fee and signed Artist's release form **mailed to: Three Cities Art Club c/o Marilyn Meredith, 41021 Southwind, Canton, MI 48188**.

Entries will be juried/judged from the original art to be delivered on **Friday, November 17, 2023 between 9 and 10 am to Westland's Gallery at City Hall located at 36300 Warren Road, Westland, MI 48185**. Each piece must be labeled on back with **artist's name, title, selling price and artist's phone number**. **ART NOT RECEIVED BY 10 AM ON NOVEMBER 17TH MAY NOT BE ACCEPTED AND ARTIST WOULD FORFEIT ENTRY FEE (subject to decision of TCAC)**.

Please print clearly on Entry Form as you wish your name to appear on show cards and in the program, include a photo of yourself and a short artist profile. Please email electronic files to [marilynmeredith@wowway.com](mailto:marilynmeredith@wowway.com); photos in JPEG format, approximately 800 DPI, less than 2 MB with artist's last name and title of art as file name: i.e. **Meredith.Flowers.jpg**.

## NOTIFICATION OF JUROR RESULTS/PICK-UP

Artists will be notified of juror's results by phone between 1 pm and 2 pm Friday, November 17. **Pick-up art which was not accepted by 2 pm\* Friday, November 17th.**

## RIGHTS AND REPRODUCTIONS

Three Cities Art Club and the City of Westland reserve the right to use provided images and photographs and reproduce all accepted entries, regardless of copyright, for the sole purpose of publicity.

## SALES

A TCAC **25% commission** will be charged on sales (**15% for TCAC members**). **Credit card sales will be assessed a transaction fee of 5% of the sale price**. Artists are responsible for paying Michigan State sales tax. TCAC sales coordinator Gwen Roth's phone number will be printed on show cards and those interested in making a purchase will contact her so she can arrange transaction at Gallery at City Hall. TCAC will pay artists as soon as reasonably possible following the close of the exhibition. If buyer wants to take art at time of sale, with the artist's permission, a "SOLD" sign will be hung in place of art.
